### **About Fairbeats**

Fairbeats is a small, grassroots music charity working with young refugees, asylum seekers and new migrants. Fairbeats began in 2009 and became a charity (Charitable Incorporated Organisation, CIO) in 2014.

Our **vision** is for a society where all refugee, asylum seeking and new migrant children and families have the opportunity to participate in musical activity to the extent they wish to. In doing so, they can experience transformative benefits of music and creativity, and their right to artistic experiences and expression is upheld.

Our **mission** is to provide relief and respite to refugee, asylum seeking and new migrant children and families through music. In doing so, we aim to be an anchor in a challenging world. We offer space and time outside the challenges of everyday existence – a safe and nurturing place for children to build friendships; express themselves and regulate their emotions; and gain skills and experiences that help them overcome adversity.

We deliver **long-term music programmes** for children and young people, in partnership with organisations including Action for Refugees in Lewisham, the Katherine Low Settlement in Battersea, and a range of music and arts organisations.

# Summary of role

The main purpose of the Chair of Trustees role is to provide inclusive leadership to the Board of Trustees; ensure that Fairbeats is fulfilling its charitable purpose, mission and vision; ensure that each trustee fulfils their duties and responsibilities; and to provide support to the senior management team (CEO and three Directors).

Ultimately we are aiming for a **Co-Chair model**, to reflect our ethos of collaboration and shared power. We are also working towards involving more people with lived experience of forced displacement in running Fairbeats. In the first instance though we are looking to appoint one Chair, who will then be involved in the recruitment of a Co-Chair.

The role is a **voluntary position** but Fairbeats will **reimburse expenses** including travel and dependent care if required.

## Main commitments as Fairbeats' Chair

- Chair 4 x two-hour meetings per year (these are currently held at Lewisham Music in Bellingham, 6.30-8.30pm every three months with the option of attending online where necessary)
- Attend a 30 minute phone/video call catch-up with the CEO a maximum of once every two weeks
- Respond to occasional emails or requests for support from the CEO and Directors in a timely manner
- Lead the process of trustees approving the annual **Charity Commission accounts** and ensure Fairbeats is complying with Charity Commission requirements
- Attend an annual away day with Fairbeats core team and trustees, and support the CEO in planning and facilitating this
- Chair/attend occasional committee task-and-finish group meetings
- Sign funding applications and agreements where required (recently this has only be required two to three times per year)
- Lead the induction of new trustees and facilitate an annual review with each trustee
- Facilitate the CEO's annual review

# About you

As an organisation committed to social justice, anti-racism, anti-oppression and decolonisation, we are looking for someone who:

- Is excited to work with the Fairbeats core team and trustees on creating systemic change in line with this ethos
- Shows a strong desire to support music-making with children and young people experiencing challenging circumstances
- Is interested in democratic and collaborative models of leadership, including co-Chaired Boards of Trustees
- Centres care for and wellbeing of everyone at Fairbeats in their approach to leading the Board of Trustees, drawing on trauma-informed practice in doing so
- You don't need to have prior experience as a Chair or trustee, and as a friendly, supportive Board it is a great place to build experience of charity governance. Finding someone with the right qualities who shares our values is most important to us, and we welcome anyone interested in being part of the Fairbeats team to express their interest.

We particularly want to encourage people to apply from the refugee, asylum seeking and new migrant communities we serve.
